When Nicole Sodoma opened the doors to Sodoma Law in 2008, it was with the intention of building a different kind of law firm. Over time, this concept has become known as, "The Sodoma Way."

In its first 12 months, Sodoma Law grew from 1 to 12 employees. With her direction, innovation, and resolve, Sodoma Law's revenue increased by more than 20% in 12 months and has continued to have year over year double digit growth. Fifteen years later, Sodoma Law has five offices across two states with 28 fearless attorneys. In 2022 Nicole added Author to her list of accomplishments when her debut book, *Please Don't Say* **You're Sorry**, was released.
